Exploring Ottawa: Hector Chamanne, Consul-General for Belgium from 1903-05 was the first occupant. From 1907-1913, Lieutenant-Colonel Francis Gourdeau occupied the residence; he was the Deputy Minister of Fisheries and Oceans. From 1913-1919, Nolan Cauchon, an engineer and noted urban planner, occupied the residence; he was the son of Joseph Edouard Cauchon. Napolean Antoine Belcourt, the Speaker of the House of Commons, was resident from 1919 until his death in 1933. The Consul-General of Argentina, Cabrera A. Munoz and his wife Sylvia occupied it from 1935-37. In 1939, Walter Jones, president of IBM Canada, was a resident. Major-General WHP Elkins occupied it from 1939-40 during which time he was the Chief Commander of Ordnance for the Canadian Armed Forces. From 1941-1947, the residence was used by the Canadian Legion War Services. From 1947 to present, the headquarters of the Canadian Lumberman's Association.

Developmental Context

This house is part of early efforts to establish residential use on Goulburn Avenue, in the eastern portion of the Colonel By estate.

Summary/Comments on historical significance

The historical significance of this house derives in part from its age (built in c. 1903), its associations with numerous important individuals (notably Hector Charmanne, Lt-Col. Francis Gourdeau, Nolan Cauchon, Hon. Napoleon Belcourt, speaker of the House of Commons, Cabrera A Munoz, Consul-General of Argentina, and Walter Jones, president of IBM Canada, as well as Major General WHP Elkins) and from its role in establishing residential use on Goulburn Avenue, in the eastern portion of the Colonel By estate.

Architectural characteristics and design

Property characteristics: Single use residential. Detached, 1 1/2 storey with rectangular plan, side entry and occupied basement. Site features consist of a driveway, a garden, a fence and stone retaining wall at front property line.

Exterior elements: Sloped hipped roof of asphalt shingles with gable ends; dormers and 1 stone chimney. Decorative roof elements include hipped dormers at sides and angled dormer at center front. Exterior stone wall with wood decorative window surrounds and stucco with half timber details at upper floor. Coursed rubble stone foundation.

Windows and doors: Rectangular wood casement with diamond panes windows. Single wood front door with with decorative wood surround.

Other features: 1 storey stone porch with stone base, stone columns and stone balustrade.

Comments:

Bellcast roof and dormer eaves. Gallery at 2nd storey side facade with wood columns, capitals, and balustrade.

Summary/Comments on architectural significance

This residence is unusual for its rock-faced stone facade and its proximity to the front property line. It is a typical mix of stylistic elements, incorporating Arts and Crafts influences in the sloped hipped roofs, dormers and front loggia and Tudor Revival elements in the stucco and half timber details at the gable ends. The massing, stone facade, decorative windows and wood detailing are additional character-defining elements and should be maintained in future renovations.
